

Guide to Special Fixed Benefit

May 1, 2020

All residents of Japan , including non-Japanese citizens listed on the Basic Resident Register as of April 27, 2020, are eligible to receive the special cash payment of ¥100,000.

Application

【Online application method (My Number Card is required)】

① via PC

When accessing from a PC, My Number Card, IC card reader writer which is compatible with My number card) are required. Then please follow the procedure from “Miner Portal” site.

② via Smartphone (some models are not supported.)

Please prepare My Number Card and follow the procedure from “Miner Portal” site.

※For details on how to apply online with My Number Card, please see Toda city office website or Ministry of Internal Affairs and Communications.

【Mail in Application】

Toda city will send you a set of application documents. Please fill in the application form, attach the required documents and reply to the Toda city office using the enclosed reply envelope. (Postage is paid by Toda city.)

【For those who wish to apply by mail and in a hurry to apply】

Please download the application form posted on the Toda city website, fill out the application form, attach the necessary documents, and send it to Toda city office. (Shipping will be at your cost.)

Examination

Toda city will check if the application form you have submitted is complete and examine your eligibility for benefits.

Notice letter

If your request gets through the examination, a payment confirmation notification will be sent to you by mail.

Payment

The benefit will be transferred to your account.

Information Regarding Application for Special Fixed Benefit

What is Special Fixed Benefit?

Special fixed benefit will be provided as a temporary support to each household suffering from failing incomes amid the spread of the new coronavirus.

Beneficiary

All residents, including non-Japanese citizens, listed on the Basic Resident Register as of April 27, 2020.

Please refer to the cautionary points about eligible for benefits.

Benefit amount

The benefit will be 100,000 yen per person

Application period

From May 1st 2020

Bank account to be paid

In principle, the payment will be transferred to the bank account in the name of the applicant (head of household)

Cautionary points

①Payment period	It takes about a few weeks to transfer of your benefit. Please confirm that there are no errors or omissions in the information you have filled in.
②About those who can be proxy:	<p>(1) A household member of the applicant and recipient as of April 27, 2020</p> <p>(2) Legal representative (the guardian of an adult, curator and assistant with granted authority)</p> <p>(3) A relative or a person who normally takes care of the applicant and authorized by the municipality to do it.</p>
③About those who transferred from Toda city after the base date:	Please apply to Toda city, because it is necessary to apply to the municipality where you were registered as a resident on the base date (April 27, 2020)
④About those who moved to Toda city on the day after the base date:	Please apply to the municipality where you registered as a resident as of April 27, 2020. The format of the application form differs depending on the municipality, so please contact the municipality before moving in.
⑤About those who died after the base date:	Those who died after the base date (April 27, 2020) are eligible for the benefits.
⑥About foreigners:	Foreigners are also eligible. However, short-term residents and illegal residents are not eligible for the benefits.

Please beware frauds that took advantage of the payment of benefits.

The government and municipalities will NEVER do any of the below:

- The government and municipalities will NEVER ask you to operate ATM(the cash dispenser).
- The government and municipalities will NEVER ask you for transfer of fees due to special fixed benefit.
- The government and municipalities will NEVER send you e-mail
and ask you to click URL for application procedure.
- The government and municipalities will NEVER ask you for your bank account information by Phone.
